Checks payable to **NATIONAL SIAMESE CAT CLUB**. Per Show Rule 6.21, all entries must be paid in Full within 10 days of entry or prior to the start of the show, whichever is first. Entries submitted in the final 10 days before the show date AND paid at check in **MUST** pay in cash. Absentee entries not paid prior to the start of the show must be paid within **TWO** weeks of the **FIRST DAY OF THE SHOW** or an additional \$40.00 late Fee will be added. **ALL ENTRIES MUST BE RECEIVED THROUGH THE CFA ONLINE ENTRY PORTAL. NO REFUNDS/CANCELLATIONS after confirmation has been issued.**

Exhibitors with security cages must purchase double cage spaces. All entries in Championship (except Novice), Premiership (except Novice), Agility (if offered), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number.

This is a CFA licensed show and all CFA show rules will be enforced. For a copy of the show rules visit <https://cfa.org/cfa-manuals/>. The club reserves the right to add judges not named in the flyer.

Cage size is 22"x22"x26". Litter will be available; bring your own litter pans, cat food, and dishes. Claws of all entries must be clipped prior to benching. It is strongly advised that all cats and kittens present in the show hall be inoculated against feline enteritis, rhinotracheitis, calici virus, and rabies (proof of rabies vaccination is mandatory in NYS). It is further recommended that cats and kittens be found negative for FeLV before entry. All entries must be free of fleas, fungus, and infectious diseases. Declawed cats are not permitted in the show hall. No kittens under the age of 4 months will be permitted in the show hall.

Show hall is heated and air conditioned. The club will not be responsible for lost or stolen articles.

Many area hotels will take pets and a list will be sent with confirmation.

PEOPLE FOOD WILL NOT BE AVAILABLE AT THIS SHOW! A list of local restaurants that provide delivery will be available.

SPECTATORS WELCOME! ALL ATTENDEES ARE EXPECTED TO FOLLOW THE CFA MANDATORY COVID-19 REQUIREMENTS AND RECOMMENDED GENERAL PRACTICES, LOCAL, COUNTY, STATE, NATIONAL AND EVENT FACILITY REGULATIONS AT THE TIME OF THE SHOW.
